

1 YEAR LIMITED WARRANTY FOR SELECT RUBBERMAID BRANDED PRODUCTS

Warranty Effective Date: This limited warranty applies to original purchases on or after April 1, 2025.

What does this limited warranty cover?

Rubbermaid Commercial Products LLC ("Rubbermaid") warrants to the original end-user purchaser that its product from the product lines listed below (each, a "Product") will be free from defects in material and workmanship for a period of one year from the date of delivery to the original end-user purchaser. This warranty applies only to Products purchased and used in the United States of America and Canada, and only to the original owner and is not transferable (except where prohibited by local law, which may include the Province of Québec). Because Rubbermaid cannot control the quality of Products sold by unauthorized sellers, in the United States this warranty applies only to Products that were purchased from Rubbermaid or a Rubbermaid authorized seller in the United States, unless otherwise prohibited by law. Rubbermaid reserves the right to reject warranty claims for Products purchased from unauthorized sellers, including unauthorized Internet sites. All failures or defects must be reported within the applicable warranty period.

Product lines covered by this warranty:

- Rubbermaid® branded trash and recycling products, excluding Roughneck and Elite product lines.
- Rubbermaid® branded sheds and outdoor storage products, excluding those covered by the Rubbermaid 10 Year Limited Warranty for Outdoor Living Products.
- Rubbermaid® branded laundry and step stool products.
- Rubbermaid® branded cleaning products, including Rubbermaid® branded buckets, brushes, mops, cloths, dustpans, and cleaning tools.
- Rubbermaid® branded closet organization products.

What will Rubbermaid Commercial Products do?

If a Product covered by this warranty is found to be defective when used as intended under normal household conditions within the specified period, Rubbermaid will provide to you, at Rubbermaid's option, a replacement Product or will issue a refund for the actual purchase price of the Product (or current retail price if the actual purchase price is not available).

How to get service? Either contact the outlet where purchased, or to make a warranty claim with Rubbermaid, submit your claim by using the "Start a Warranty Claim" tool on the contact us page at <https://www.rubbermaid.com/support/contact-us>.

What to submit for a warranty claim? The original purchaser must provide proof of purchase (either a bill of sale, receipted invoice, or other proof that the product is within the applicable limited warranty period) and proof of delivery date if different than date of purchase, along with a full description of the claimed defect. Rubbermaid reserves the right to request photographic proof of the alleged Product defect and/or request that the Product in question be shipped to Rubbermaid (postage provided by Rubbermaid) to inspect the Product or to aid in quality control efforts.

What does this warranty not cover?

This warranty does not apply to Product that has been damaged as a result of normal wear and tear, insects, animals or rodents, use of force, incorrect handling, inappropriate use, abuse, neglect, accidents, impact from foreign objects, vandalism, pollutants, set-up on an un-level foundation, alteration, painting, fading, assembly not in accordance with the User's Manual, or damage caused as a result of storage above the capacity limits of the Product, improper maintenance, accident, or other misuse. This warranty does not apply to Product that has been damaged as a result of acts of God, including, but not limited to: wind, hail, storm, tornado, hurricane, heavy snow, ice, blizzard, flood, or fire effects. This warranty does not apply to Product that has been damaged as a result of structural parts and components not supplied by Rubbermaid being used. This warranty does not apply to "Normal Weathering". "Normal Weathering" is defined as exposure to sunlight and extremes of weather and atmosphere which will cause any colored surface to gradually fade,

chalk, or accumulate dirt or stains. Commercial use or use other than for personal or household purposes is not covered by this warranty.

Do NOT attempt to repair or modify the Product to remedy any damage or defect covered by this warranty. Rubbermaid reserves all rights to decline coverage if the defect or damage was caused by unauthorized attempts to repair or modify the Product. Rubbermaid expressly excludes from this warranty and denies liability for defects or damage caused by repair or modification.

There are no warranties which extend beyond those stated herein. THIS WARRANTY IS EXCLUSIVE AND IN LIEU OF ANY OTHER WARRANTY, WRITTEN OR ORAL, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. THE DURATION OF ANY IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, IS EXPRESSLY LIMITED TO THIS WARRANTY PERIOD. Some States or provinces do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

THE ORIGINAL PURCHASER'S EXCLUSIVE REMEDY FOR BREACH OF THIS WARRANTY OR OF ANY IMPLIED WARRANTY OR OF ANY OTHER OBLIGATION ARISING BY OPERATION OF LAW OR OTHERWISE SHALL BE LIMITED AS SPECIFIED HEREIN TO REPLACEMENT OF THE PRODUCT OR REFUND. IN ANY EVENT, RESPONSIBILITY FOR SPECIAL, INCIDENTAL AND CONSEQUENTIAL DAMAGES IS EXPRESSLY EXCLUDED. Rubbermaid SHALL NOT BE LIABLE FOR ANY SPECIAL, CONSEQUENTIAL OR INCIDENTAL DAMAGES WHATSOEVER. Some states or provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

This warranty gives you specific legal rights, and you may have other rights that vary from State to State or province to province.
