- 2. The immersion suit is to be fitted with retro-reflective material in accordance with IMO Resolution A.658 (16)
- 3. Instruction for use shall be provided with each Immersion Suits as prescribed by SOLAS Regulation III/35 one or more additional copies shall be provided for inclusion in the Vessel's Training Manual
- 4. As prescribed by SOLAS Regulation III/36 and where applicable, Immersion Suit shall be maintained as prescribed by manufacturer's instructions
- 5. Each Immersion Suit and its packaging shall be permanently and clearly marked at least with: identification of the manufacturer and the model designation, the weight and height range of persons suitable to wear the immersion suit, simple donning instructions, and approval information
- 6. Each Immersion Suit shall be supplied with an explanatory leaflet containing instructions for care and maintenance of the immersion suit. When carrying out the inspection of immersions are required by SOLAS Regulation III/20.7.2 consideration should be given to IMO MSC/Circ. 1047 on Guidelines for Monthly Shipboard Inspection of Immersion Suits and Anti-exposure Suits by the Ship's Crew
- 7. An approved light and whistle meeting the requirements of LSA Code Regulation II/2.2.3 and II/2.2.1.14, respectively, are to be fitted. The light or lights selected to be attached to the immersion suit shall be tested to the requirements of IMO Resolution MSC.81 (70), I/10.3.3 to confirm the adequacy of their means of attachment
- 8. The on board arrangements and installation of this product are not part of this design appraisal or certificate. All such arrangements are to be to the satisfaction of the Surveyors attending on board
- 9. If the specified standards are amended during the validity of this certificate, this product type is to be reapproved prior to it being supplied to vessels to which the amended standards apply
- 10. Production items are to be manufactured in accordance with either an approved Production Quality Assurance system (Module D) or Product Quality Assurance (Module E) or Product Verification (Module F) of the Marine Equipment Directive. **The wheelmark cannot be affixed to the product until a conformity assessment module is in place**
- 11. Production tests are to be conducted in accordance with the applicable requirements of IMO Resolution MSC.81(70), Part 2 and be recorded by the manufacturer in accordance with either the approved Production Quality Assurance system (Module D) or Product Quality Assurance (Module E) or witnessed by the Notified Body (LRV) as required by the Product Verification (Module F) of the Marine Equipment Directive. This does not preclude any further testing to additional requirements of the Marine Administration of the country where the ship is registered (i.e. the flag state) or those acting on behalf of that Administration
- 12. Each item, batch or lot of the equipment is to have the "Mark of Conformity" affixed and be issued with a "Declaration of Conformity"
- 13. Should a change of Place of Production from that stated below be required i.e. where the stages of manufacture/assembly/testing of this product take place, the new Place of Production is to be advised to us prior to the change taking place. This Certificate will require to be updated for Approval to be maintained
